RE: TD Locals Reminded to Report Election Results

This memo is intended to remind Locals that have not yet reported the results of their Autumn 2023 elections to promptly do so. Our Constitution requires that State and District Legislative Boards conduct their Quadrennial Reorganization Meetings between January 1 and May 31 of this year; therefore, it is imperative that this office possess an accurate listing of Legislative Representatives.

In order for a Legislative Representative to represent their Local at their State or District Legislative Board's meeting and elections, their Local must have completed the elections for the Legislative Representative position and reported the election results. If the Local has not completed elections for the Legislative Representative position, but has completed and reported the results of the Alternate Legislative Representative position, the Alternate Legislative Representative may represent their Local at their State or District Legislative Board's meeting and elections. A list of Locals that have not reported elections for the position of Legislative Representative is attached.

It is requested that any outstanding election results be reported by utilizing the TD Connect Local Portal under the following path: Local Union Portal-> Reports-> Officer Election/ Vacancy. Select the SMART University Tutorial link for further guidance.
