Local S&T/President In-Person Workshop

Description: This workshop is the most comprehensive and thorough training option for Local **Treasurers and Presidents**. The workshop is 4 days long for Local Treasurers. The portion for Local Presidents is only the first day and a half. The two groups will be combined on the first day and a half. Each Local Treasurer will have a Local evaluation one-on-one session with one of the trainers on the last day of the workshop. Local Presidents should plan departure flights for after 3 pm, day 2. Local Treasurers should plan departure flights for after 7 pm, day 4. Unless held at the National Training Seminar, there is no cost to register for this workshop.
